ANNUAL BUDGET HEARING

After welcoming everyone, the Budget Hearing was called to order at 7:00 p.m. by the Board of Education President, Mr. Beardsley. The Board Candidates were introduced. There are two vacant seats for three year terms; Christine Bianchi and Laura Geary. The election will take place on Tuesday, May 21, 2019 from 8:00 a.m. to 8:00 p.m.

Mr. Beardsley turned the Hearing over to Mr. Furletti, Superintendent and Mr. Liess Jr., Business Official; who presented the 2019-20 Budget proposal. A power point was also shared which included the district's continued goal of "Maintaining a high-quality educational program for our students, while remaining fiscally responsible to our community". It was also shared what YCS has to offer, budget spending, data trends in the tax levy. The presenters pointed out that York School brings personal attention in a tight knit school community and increasing opportunities for our students academically, athletically, in the fine arts department, in addition to establishing mindfulness, character education and good citizenship.

The Board of Education has adopted a Budget for the 2018-19 school year in the amount of \$17,053,835. The corresponding tax levy is 1.51% which is below the tax cap at 2.3%.

At this time, the community had an opportunity to ask questions; which there were none.

Mr. Furletti and the Board of Education thanked everyone for attending. Mr. Beardsley ended the Budget Hearing at 7:15 p.m.
