3. Input from Athletic Directors related to shared athletic teams was presented.

Benefits include: increased opportunities for students; alternative to one district adding a whole team; sustaining certain teams; better use of each district’s facilities; possibility to add new teams. York does not have golf, cross country, or boys volleyball (Pavilion does). Pavilion does not have swimming or football (York does). York’s numbers are struggling for boys soccer, girls soccer, football, and wrestling. Pavilion’s numbers are struggling for wrestling, boys volleyball, and cross country.

Concerns include: state formula for shared teams is a two-year pilot; school identity lost; would costs be shared for uniforms, equipment, transportation, coaches, officials?; coaches upset at losing a position; students/parent upset with lost playing time; policy alignment for academic eligibility and drug/alcohol use; articulating the rationale and criteria for shared teams.

The committee will invite the A.D.s to our next meeting. The committee would like the following addressed:

- ✓ What do the numbers look like under the state's formula for sharing teams?
 - ✓ What are the section, league, and your personal opinions on the topic?
 - ✓ If recommended, which teams would you start with?
4. The committee brainstormed a list of activities that may be targets for sharing:
 - Trips to D.C. (York Student Board / Pavilion's Close-Up Program)
 - Ski Club
 - Various Band and Chorus Ensembles
 - Musicals or Plays
 - Extracurricular Clubs (like FFA)
 5. The committee established some time guidelines / categories:
 - Short Term (next 1-3 years) – athletics, extracurriculars, academic courses, shared personnel
 - Long Term (next 4-7 years) – more of the above, possibly UPK, elementary summer school merger
 6. The committee identified an initial timeline:
 - 2013-14 school year – athletics and extracurriculars
 - 2014-15 school year – academic courses (in person or through distance learning)
 7. Next meeting scheduled for June 3, 2013, 6:00 P.M., at Pavilion. Athletic Directors and Principals to be invited. Input from Transportation Directors to be shared. Future meetings on each campus should involve a site walk-through.
