## Minutes

## Part I: Shared Academics

- The shared AP World History class is in its second year. New technology and an aligned bell schedule have improved the delivery of this course. This year's enrollment is 18 (10 from Pavilion). This will be the last year this shared course is offered because York is moving to offering this course over two years while Pavilion will stay with a one year course.
- The sports marketing class (which we hoped to share this year) is being offered separately on each campus this year. A combined field trip to New Era Stadium (Buffalo Bills home field) did occur. We will look to align the scheduled time of this course so it can be fully shared in 2017-18.
- The possibility of sharing an AP English course in 2017-18 will be discussed.
- Pavilion is planning to revive some of its agriculture courses as business/Ag. courses. Pavilion also hopes to establish a Future Farmers of America (FFA) club. We will investigate sharing of these courses and the FFA club.
- Several other sharing opportunities continue to be successful: shared dances, shared SAT/ACT prep courses, and a shared drug education assembly.
- The committee would like both districts to consider more shared field trip opportunities in the future.


## Part II: Shared Athletics

- Both districts’ Athletic Directors shared participation numbers for shared fall 2016 sports teams:

- Another area district asked our committee to consider their joining our boys' football program. This would make a three-school merged team which would allow for enough participation at all three levels (modified, JV, and varsity). The A.D.s see this as a positive move in terms of more total athletes being able to participate at their ageappropriate level. The concerns would be more logistical, in terms of scheduling and transportation. The A.D.s explained the current NYS rule for sectional classification of merged teams. Under these rules, if we went to a three-school merged team, we would be classified as a Class C school for sectional purposes.
- Both districts asked to discuss this three-school football merger with their full respective Boards of Education before making a final decision. Boys soccer would not be impacted.
